We did vote on two proposed bylaws changes. The first was a wording change to the bylaws necessitated by our move, a few years back, to one, rather than two, meetings per year. The second allows the Board to conduct its meeting in "a manner agreed upon by the Board," so that the bylaws reflect the Board's practice of conferring by phone and other means, in addition to face-to-face. Unfortunately, there were no nominations for our new Library Innovation Award, which replaced our Librarian of the Year Award. Sadly, this is the second year in a row that we have not given an award. ### **Treasurer's Report to Membership and Annual Report 2012-2013**

Despite the slow economic recovery, ENY/ACRL remains in healthy financial condition.

Our checking account balance as of April 30, 2013 was **\$18,300.85**.

#### Spring Conference 2012, Mohawk Valley Community College, Utica, NY

ENY/ACRL received 107 paid registrations and \$1,800 in vendor support.

Total Conference Income: \$5,545.00

Total Conference Expenses: \$6,182.21

Net Loss: \$ 637.21

The 2012 Spring Conference was well attended. The Conference programs were also very well received even though we had a slight loss. Based on our financial status, ENY/ACRL will be able to continue providing vibrant programs for our members. With the inflation, the Board discussed and decided to raise the conference registration fee from \$35 to \$40 this year. We will continue to subsidize our conferences to keep the direct cost to membership as low as possible.

It has been a great pleasure to serve as the Treasurer. I'd like to acknowledge Dung-Lan Chen for the efforts she made in seeking vendor support for the Spring 2012 conference.

### **Membership Chair's Annual Report 2012-2013**

As of May 13, 2013, ENY/ACRL has 210 active members representing 52 institutions, six companies, two regional library councils, one higher education initiative, one state library, one novitiate, three governmental units and three library graduate programs. We added ten new members since August and an additional 48 availed themselves of the conference registration + membership option which supports both new memberships and renewals. Although our institutional representation has dipped somewhat, the number of new memberships is steady and our overall membership total remains healthy and stable.

Our membership year follows the academic calendar: September 1 – August 31. If your membership expires on August 31, 2013, you will receive an email renewal request toward the end of the summer. Membership renewal and secure payment options are available online. Once your payment arrives via PayPal, personal check or institutional check, you will receive an email confirmation along with our most current Membership Directory. I continue to work with my Board colleagues to investigate secure options for an online directory that provides data that is constantly updated and most current.

If you serve as an institutional liaison (IL) for your organization, summer is a perfect time to don your IL hat, talk with your colleagues about membership, review your institution's entries in the Annual Membership Directory for accuracy and send corrections, retirements, job changes, relocations, etc. to me (your friendly Membership Chair) by the end of July. This will insure that we share our most current information in the Membership Directory when the renewals start rolling in in September.
