Our checking account balance as of April 30, 2014 was **\$20,619.21**.

ENY/ACRL received 105 paid registrations and \$1,800 in vendor support.

As of May 14, 2014, ENY/ACRL has 202 active members representing 51 institutions, four companies, two regional library councils, one higher education initiative, and two governmental units.

Perhaps the most eventful item over the past year just occurred with the announcement that the New York State Higher Education Initiative (NYSHEI) will cease as a legal entity at the end of their fiscal year.

NYSHEI had formed a formal information sharing agreement with ENY/ACRL this year. The Government Relations Chair attended the NYSHEI Board meetings (four this last year) in an effort to increase channels of communication. NYSHEI Executive Director, Jason Kramer, would provide updates of advocacy and legislative topics to ENY/ACRL for Board meetings as well as our newsletter. Unfortunately, we have lost that avenue of communication and support. NYSHEI had been working on advocacy for the Taxpayer Access to Publicly Funded Research (TAPFR) legislation as well as an Open Textbook initiative. TAPFR has been wrapped into a larger Open Data bill which is still making its way through the Legislature. The Open Textbook initiative is in the early states of development but has developed a white paper on e-textbooks to help inform policy makers. At this point the future of this endeavor seems uncertain. At present, the white paper is available on the NYSHEI site at: http://www.nyshei.org/initiatives-2/electronic-and-open-textbooks/

The ACRL Legislative Agenda for 2014 includes three items of emphasis where legislative action is pending or upcoming. Ranked in order of importance the three agenda items include:

- 1) Access to Federally Funded Research
- 2) Net Neutrality
- 3) Curbing Government Surveillance

Other items mentioned of importance include: Fair Use, "Making Available" Rights, Preservation and reproduction exceptions, Orphan Works, and The Digital Millennium Copyright Act. Legislative action on these topics is not expected in the near future however they are being monitored.
